Call to Order and Minutes

LPA Operations

Automated Biometric Identification System (ABIS) Monitoring Memo –

Katrin Osterhaus, IT Audit Manager, presented findings from the monitoring memo and answered questions from the committee. The memo will be distributed to all legislators.

2024 IT Monitoring Plan – Katrin Osterhaus, IT Audit Manager, presented the annual IT project monitoring plan for 2024 and answered questions from the committee. That plan would have LPA staff monitor the Kansas Department of Health and Environment's (KDHE's) Eary Childhood Data Integration and System Enhancement project. Senator Tyson made a motion to approve the plan. Senator Petersen seconded the motion; motion carried.

2024 IT Security Plan – Katrin Osterhaus, IT Audit Manager, presented the annual IT security plan with two recommended options for reviewing agencies in 2024. The committee discussed the pros and cons of both approaches and other potential options. Senator Tyson made a motion to approve option B to conduct comprehensive IT security audits for a limited number of state agencies and school districts, using a confidential report format and including a 4 to 1 ratio of school districts. The motion also included a recommendation for the Joint Committee on Information Technology to consider what approach they think would be best and to report that suggestion to LPAC. Representative Williams seconded the

motion; motion carried.

Proposed Legislation – Chris Clarke, Post Auditor, reminded the committee that they directed staff to prefile a bill in both chambers to eliminate several statutory requirements that affect LPA, including required audits of the 911 system implementation, KPERS, and economic development incentives. If the bill passes, Senator Thompson requested that LPA staff periodically remind the committee how much time has passed since staff last audited these topics.

Legislative Report Meetings Plan – Chris Clarke, Post Auditor, discussed how the division plans to comply with LPAC Rule 1-5(f). That includes which committees staff intend to meet with regarding audits released in the last year.

Data Mining Results – Matt Etzel, Performance Audit Manager, discussed results from the data mining team's work in 2023 and answered questions from the committee.

Audit Recommendation Report – Matt Etzel, Performance Audit Manager, summarized the annual recommendation follow-up report to comply with LPAC Rule 3-5.

Performance Audit Requests

Performance Audit Requests – Kristen Rottinghaus, Deputy Post Auditor reviewed two audit proposals requested by legislators prior to the committee's meeting and committee procedures for proceeding. Representative Jason Probst requested a performance audit of hospitals' compliance with the Kansas Lay Caregiver Act. Representative Samantha Poetter Parshall requested a performance audit of school districts' state and local expenditures and budgets.

After discussion and questions, Representative Williams made a motion to approve a limited-scope audit of one to two school districts' expenditures and whether they comply with state law. Senator Tyson seconded the motion; motion carried. Staff will work with the requesting legislator to develop the limited-scope audit and bring it back to the committee at a future meeting.

Representative Probst made a motion to approve the Kansas Lay Caregiver Act proposal for staff to begin before the spring 2024 meeting. Senator Ware seconded the motion; motion carried. **Executive Session**
